Terms and Conditions:

All the goods must be offered with standard warranty.

1. The offered rates should be inclusive of all applicable taxes. Tender Quoted rates will applicable till 30 June 2023.
2. All the taxes applicable will be deducted from the suppliers as per relevant rule.
3. Bid Security @ 5 % of offered rate addressed to the District & Sessions Judge Nowshera is required to be attached with each item of the tender, Bidding documents & separate bids shall be offered for each item, without call deposit tender shall not be entertained.
4. The bidder must provide the certificate of authorization with the bidding documents. The bidder must submit an affidavit that they are not black listed with any Govt / Semi Govt organization and that the supplied item will be genuine.
5. The bidder will must provide certificate with clear indications that no information has been concealed, in case distortion of facts are detected, it would be sufficient cause to disqualify the bid & will lead toward blacklisting of the perspective bidder.
6. Single stage two envelope method will be used.
7. Supply items shall be strictly according to specification obtained from office; otherwise, the bid would stand cancelled. Successful bidder will be bound to supply items within specific days after the issuance of supply order failing which or supplying below standard items would lead to cancellation of supply order and the Call Deposit to be forfeited.
8. Incomplete application / bid will not be entertained. The committee reserves the right to reject or discontinue the tender proceedings as well as to reject any or all the applications with the reasons / grounds of rejection to be communicated to the bidders upon requests as per rule 47(1) of KPPRA rule 2014. In case of cancellation of supply order and new supply order will be issued to next lowest bidder.
9. Both Technical Bids and Financial Bids must be submitted in two separate sealed inner envelopes marked "*1-Technical Bid*" and "*2-Financial Bid*" which should be packed in one outer sealed envelope.
10. Last date of Bidding documents reach to this office will be on **10th of June 2023 till 11:00 AM**. The Tenders will be opened on the same last day at **11:30 A.M** in presence of the bidders or the representative of the bidder.
11. Quality shall be as per provided specification & Detail or better than that.
12. Vendor will be responsible to provide defect free and brand-new items. in case of inferior quality, the performance guarantee may be forfeited.
